Consequent to above considering the realistic time elapsed of about 10 months after the last cut-off date fixed by council that is 31/12/2020, President, MSPC directed Registrar to call for an extra-ordinary meeting of the council to discuss the current scenario on the Election of the Council. The Council, in the meeting held via online mode on 18/11/2021, examined the issue and noted that there is a considerable time elapsed after the cut-off date fixed earlier that is 31/12/2020. To avoid probable consequences which may arise due to the time elapsed and in view to that the Pharmacists those are newly registered or those who have renewed or re-entered their registration during the period of about ten months after 31/12/2020, the cut-off date fixed earlier are not deprived off their right to cast vote or contest the election, the Council took a decision to revise the cut-off date. Therefore, the Council resolved to revise the cut-off date as 18/11/2021.

In view of the aforesaid resolution of revision in cut-off date by the Maharashtra State Pharmacy Council and in supersession of the notice issued and published in the Gazette of the Government of Maharashtra dated 08.03.2021, a fresh notice of publication of Electoral Roll is hereby issued. All concerned are requested to take a note of the following notice published as required under Rule 4(2) of the MSPC Rules, 1969.
